Dear Potential Sponsor,

Thurston County Inclusion's (TCI) mission is to provide opportunities for youth with and without disabilities to create, build, and strengthen relationships that will last a lifetime. 2023 will be the third year of our summer camp. Each year, we have continued to expand and our programs continue to fill quickly. We are planning to have 130 participants this year with the support of 50 volunteers, up from 100 participants last year. We are also adding a third session this year to help meet the need in our community. Like all of TCI's activities, this camp is free to participants.

Our programs served a diverse population representing over 42 elementary, middle and high schools. Our participants ranged in age from 5 to 21 years old and volunteers ranged from high school students to retired community members. Over the course of 7 weeks last summer, we saw such growth from all of our participants and volunteers. We witnessed participants becoming more comfortable participating in our activities and volunteers taking on new roles confidently. We asked our parents and volunteers about their or their camper's experience at camp. Here are a few responses:

*"Watching my son grow as the weeks progressed has been incredibly fulfilling! I was so grateful to have the opportunity to have a safe and inclusive place for my son to play for a little bit every week, as I am a full-time working single mom. I can't wait to come back next year." – Parent of a participant with a disability*

*"My child is not a fit for many outside groups, even Special Olympics but this has engaged him and he participates as little or as much as he likes. Varied activities keeps him interested." – Parent of a participant with a disability*

Thurston County Inclusion is one of the only organizations in our community to serve both youth with and without intellectual disabilities. We seek to create an environment that adapts to our participants, rather than the participants needing to adapt to our environment.
